The Virtual Platform for Legislation on Women's Economic Autonomy and Empowerment in Ibero-America was created with the intention of encouraging action to repeal discriminatory laws and promote the adoption of regulatory frameworks that are conducive to women's economic empowerment in 8 key areas:

- 1) Gender equality and non-discrimination;
- 2) Freedom of choice of employment;
- 3) Equal pay;
- 4) Maternity protection;
- 5) Paternity leave;
- 6) Social security;
- 7) Care and;
- 8) Paid domestic work.

To ensure that the Platform is kept up to date, this form is made available to facilitate the collection of information on legislative advances in the area of women's economic autonomy and empowerment in the 22 countries of the Ibero-American community.
